### 17-050 BUDGET AND FINANCE:

050.1 Financial Reports & Expense Listing

Chief Executive advised that a preliminary report from the Accountant indicates that Council is likely to have a \$97,000 deficit. He noted that a main cause was the decrease in Council's licence income. It was recognised that the 4 new licence categories at discounted prices was a major factor in the decrease in licence income. He advised that external expenditure was close to budget. Chief Executive was commended on his financial efficiency and honesty of fish and game budgets and funds.

- LAKE BENMORE 1. FIVE AERIAL COUNTS OF LOWER OHAU AND TWIZEL RIVERS
  - 2. SINGLE AERIAL COUNTS OF TEKAPO RIVER, GRAYS RIVER, MARYBURN, AHURIRI RIVER, OMARAMA STREAM AND THE SPRING-FED STREAM ON THE TRUE LEFT OF THE AHURIRI MOUTH,
  - 3. FIVE GROUND COUNTS FOR MINT CREEK AND ONE GROUND COUNT SURVEY OF SHEPHERDS CREEK AND FRASER STREAM. THESE STREAMS ARE NOT SUITABLE FOR AERIAL SURVEY.
  - 4. THAT MERIDIAN BE APPROACHED FOR FUNDING.

### LAKE AVIEMORE AND LAKE OHAU TRIBUTARIES

1. SINGLE GROUND-BASED PEAK COUNTS AS PER NORMAL.

It was <u>AGREED</u> that if Meridian do not wish to fund the project that Fish and Game would continue to undertake the first year of the survey.

### 17-052 DOC LIAISON:

D Winterburn updated Council on various works undertaken by DoC including:

- Whitebait season one warning has being issued.
- Rangitata predator trapping is progressing well with 2 x 3 year staff positions being advertised.
- DoC, LINZ, ECan and runholders are working together on the Braided Rivers Programme. Each agency used to work independently on this but working together has meant better management and results.
- Wilding Pine Government have given funding so work is continuing on clearing them. This year effort will be concentrated in the Rakaia area.
- Goose cull a request is usually received by runholders to cull geese at Lake Heron at this time of year. DoC will have a ranger attend on the day if a cull goes ahead.
- Mudfish discussion ensued about whether it was valid to say mudfish is a threatened species.
- LWIS and Bortons pond. A query was put to D Winterburn on the situation where it's believed DoC would not sign off the go-ahead for the fish barrier. G Rooney declared his conflict of interest on this matter. D Isbister also declared his conflict of interest as he is a shareholder of LWIS. D Winterburn advised that he believed there was more to the situation and had information on this issue. He undertook to provide it to Fish and Game's Chief Executive. L Koevoet offered to provide D Winterburn with a copy of a letter sent to him from the Regional Council.

D Winterburn left the meeting at 8:45 pm.

### 17-053 OPERATIONS AND STAFF REPORTS:

053.1 Activity Reports & Operations Reports (8.1)

Staff responded to general queries from Councillors related to topics reported in their activities and operations reports. Topics included:

- Prosecutions Chairman reminded Councillors on Council policy where matters of prosecution and compliance are the sole responsibility of the Chief Executive and Councillors are not to get involved in these matters.

### 055.1 Coarse Fishing Request (JG)

Chief Executive provided Council with a letter from 6 coarse fishing anglers who requested they be approved to test for fish population and coarse fishing waters in the Central South Island Region using normal recognised coarse fishing methods including laying of ground baits.

Council were concerned from an operational, compliance and precedent setting point of view. The only provision under which going outside the set Angler Notice regulations is used is for NIWA for scientific purposes. Discussion ensued as to the pros and cons of this request and it was:
