CONFLICT OF INTEREST REGISTER

Purpose

A standing agenda item to disclose any Councillor ("Member") Conflict of Interest or potential Conflict of Interest, and record this in the Councillor Conflict of Interest Register.

Background

The Hawke's Bay Fish and Game Council has developed a policy to deal with Conflicts of Interest and must provide a standing agenda item to allow Councillors to disclose any Conflict or highlight any potential conflict. The "Interest Register" ring binder will be circulated in the first part of each meeting for Councillors to record any interests. The Council should then discuss how it wants to deal with any interest or perceived interest identified.

Conflict of Interest (refer s2.7 Governance Policies) means when the member can be shown to have actual bias or apparent bias in respect of a matter¹ i.e.:

- (i) A member can be shown to have actual bias when a member's decision or act in relation to a matter could give rise to an expectation of financial gain or loss (that is more than trivial) to the member (and/or to the member's parent(s), child(ren), spouse, civil union partner, de facto partner, business partner(s)/associate(s), debtor(s) or creditor(s)).
- (ii) A member can be shown to have apparent bias when a member's official duties or responsibilities to the Council in relation to a matter could reasonably be said to be affected by some other interest or duty that the member has.
- (iii) A member's "interest or duty" includes the interests of that member's parent(s), child(ren), spouse, civil union partner or de facto partner that may be affected by the matter at issue. It also includes the interests of a person with whom the member has a close, personal relationship where there is a real danger of personal favouritism.
- (iv) There is no Conflict of Interest where the member's other interest or duty is so remote or insignificant that it cannot reasonably be regarded as likely to influence him or her in carrying out his or her responsibility.

A potential conflict of interest (refer \$2.8 Governance Policies) arises when:

(i) There is a realistic connection between the member's private interest(s) and the interest(s) of the Council;

^{1 &}quot;Matter" means:

⁽i) The Council's performance of its functions or exercise of its powers as set out in Part 5A of the Conservation Act 1987, subject to the Council's statutory purpose set out in section 26P(1) of the Conservation Act; or

⁽ii) An arrangement, agreement, or contract made or entered into, or proposed to be entered into, by the Council.

- (ii) The member's other interest could specifically affect, or be affected by, the actions of the Council in relation to a matter:
- (iii) A fair-minded lay observer might reasonably consider that the member's private interest or duty may influence or motivate the actions of the member in relation to a matter; and
- (iv) There is a risk that the situation could undermine public trust and confidence in the member or the Council.

Conflicts of Interest should be dealt with as follows (refer s1.13 Standing Orders):

- 1.13.1 Every member present at a meeting must declare any direct or indirect conflict of interest that they hold in any matter being discussed at the meeting, other than an interest that they hold in common with the public.
- 1.13.2 When a conflict of interest arises in respect of a matter, the affected member will:
 - (i) not vote on issues related to the matter;
 - (ii) not discuss the matter with other members:
 - (iii) conform to the majority view of other members present as to whether to be excluded from discussions regarding the matter and/or leave the room when the matter is discussed;
 - (iv) not, subject to the discretion of the Chairperson, receive further papers or other information related to the matter.
- 1.13.3 Where a member can be shown to have a potential conflict of interest, the Council (excluding the affected member) will determine an appropriate course of action, which may include the following:
 - (i) applying some or all of the actions applied to a member with a conflict of interest (set out in 1.13.2 i) iv) above);
 - (ii) provide a written explanation outlining why there is no legal conflict of interest that can be made available to all Fish and Game Councils, licence holders and other interested parties.
- 1.13.4 The conflicted member will be given the opportunity to be heard by the Council on the points raised and the member's submissions will be taken into consideration by the Council.
- 1.13.5 The minutes must record the declaration and member's subsequent abstention from discussion and voting.

Councillors should take this opportunity to disclose any Conflict of Interest they are aware of now and record it in the circulated Conflict of Interest Register. If during the course of the meeting a conflict or perceived conflict is recognised, then this should be disclosed at that point in time.

Recommendation

That Councillors disclose any Conflict or potential Conflict of Interest, record it in the Interest Register, and Council agrees on how to deal with any Conflict of Interest raised. The register is to be signed at each meeting by all Councillors regardless of whether Councillors have a conflict of interest or not.

Management Report for Fish and Game Council Meeting 14 February 2023

Population Monitoring

This has been difficult in the case of Paradise Ducks and Black Swans. We were unable to obtain a plane here in Hawkes Bay and whilst we tried to work with Eastern and Wellington to utilise their resources this did not work out for a variety of reasons ie non availability of staff and plane.

Given the recent floods that have gone through the Hawkes Bay Rivers we are planning to try and obtain trout population data from the main rivers.

I am liaising with other regions to determine what we could do to ascertain whether the floods have had a detrimental effect on the trout population.

We are currently progressing with the duck banding.

Curriculum Presentation

On Tuesday 21 February we will be hosting a presentation in conjunction with Tamatea High School of the Curriculum that has been prepared. There will be approx. 6 schools invited with likely 2 teachers from each school. In addition, we have invited Ngati Kahungunu, Mangaharuru and education staff from HBRC and EIT.

This will be the kick start to the Education Programme.

Biodiversity Jervoistown Group.

On Sunday 26 February we are hosting the above group here at our facility from 11.00 am through to 2.00 pm. This will entail possibly up to 30 people going around the facility here and we will shout them some sausages and meat patties for lunch.

A number of these people are our regular volunteers here at the nursery.

Kids Fishing

We are planning to hold a further Kids Fishing day on Sunday 19 March.

This time it will be based on the large pond as we recently released approx. 400 trout into it.

There will be two stations from which to fish so we will be able to host more children than usual.

We intend to increase the charge per child from the current \$5.00/head to \$10.00/head.

As a comparison the same cost at the TNTC in Turangi is now \$50.00/head

Of course, we will be looking to volunteers to assist with the day.

<u>Beach Raking</u>

Given the concerns from Central Hawkes Bay Anglers about this practice and the fact that the study commissioned by Fish and Game was inconclusive, we organised a meeting with the angler's club and representatives from the HBRC in Waipukurau.

This was held on 25 January, and I think it went very well with the club pleased with Fish and Game for facilitating the meeting.

Game Farm Development

We have commenced clearing out the rubbish that has just been left in a number of the old sheds on site. It is almost as if someone has had a shed so throw some rubbish in it.

We want most of this done prior to the hosting of the curriculum presentation.

We have taken advice, (thank you Ross) on the state of four of the sheds onsite, which with their concrete floors and block walls are considered suitable for converting into bunk houses and/or kitchen facilities.

Some of the other old sheds will be demolished as some of them are potential hazards.

In the large aviary we are proposing to have this utilised by community groups for propagating native plants for their own planting. There is approx. 400 sq metres of area. It would also be used by our volunteers as an extension of the current shade house. I

Structurally it is in very good condition with metal posts set in concrete and completely covered by netting. Once we clear out the weeds and rubbish it will be very suitable and by utilising the community it will assist Fish and Game on the issue of Social Licence.

We do believe that the whole facility needs a change of name. It has traditionally been known as the Game Farm which is not really relevant any longer.

We have gone out to the local anglers clubs seeking suggestions but our thinking is the new name must contain Hawkes Bay Fish and Game and should contain the word Education.

Any suggestions on this would be welcome.
