# **INTRODUCTION**

## 1. Welcome

The Chairperson in welcoming everyone extended a welcome to new appointees (Nigel Juby, Paul Shortis, Dan Isbister and Colin Weatherall) for whom this is a first NZ Council meeting as appointees. He also wanted the minutes to record the Council's appreciation and acknowledgement of Colin Sherrard, Andrew Morris, Paul Dixon-Didier, Ron Stuart, Matthew Hall and John Jillett for their contribution during the current term on this council.

With this meeting being held in the Eastern Fish and Game Council office, it is fitting that a past Eastern Chairman, Council members and Manager join the meeting.

## 2. Apologies

# 3. Introductions of Eastern Staff present at the meeting

Any Garrick invited his Eastern staff to introduce themselves: Lynne Sands, John Meikle, Matthew McDougal, Lloyd Gledhill, Anthony van Dorp, Kate Thompson and Barry Roderick (past Chairperson, Eastern F&G).

NZ Council then introduced themselves.

# 4. Conflicts of Interest Register

Councillors now sign the register and identify whether there were any topics to be discussed at this meeting they perceive to be a potential conflict of interest (COI). A COI sheet was passed around at the meeting for people to note any conflicts with the listed November agenda items.

# 5. Introduction by Eastern

Andy, as the Eastern Manager, explained the area managed by Eastern Fish and Game Council and its diversity of both fish and game species. The issues experienced are like elsewhere in the country - water quality and urban expansion. The debate on indigenous vs introduced species is present and ongoing. Access to fish and game is also a feature, along with declining licence holder participation, especially for fish. Thirteen lakes make up the Rotorua area, with eleven stocked, hence the hatchery at Ngongotaha. A cultural influence is strong in the region, with 40+ iwi groups. The skill set within Eastern staff is very effective with staff also contributing nationally – Carmel Veitch (finance), Kate Thompson (licence data), Anthony van Dorp (compliance), Matt McDougall (game bird research), Matt Osborne (Fish research).

The Eastern F&G Council recognises the need for more national policy and SOPs to allow the organisation to work together and not duplicate resources.

# 6. Confirmation of Minutes from 21 & 22 September 2018 Meeting

Nothing was identified in the minutes requiring further resolution.

# 7. Review of Accumulative Action List from Previous Meetings

No further action was recorded.

A question was asked about when the in-house legal team will be established, and the CEO replied it's something he will be working on in the next year.

# 8. Annual Report and Financial Statement for year ended 31 August 2018

The purpose of considering this item is to adopt the Performance Report for the New Zealand Fish and Game Council for the year ended 31 August 2018. The report was completed and audited by Grant Thornton. Accounts are now in a more robust state than they were. A net deficit of \$210,010 was reported for the year.

# 9. NZ Council 2018/19 Bi-Monthly Financial Report No. 1

The purpose of this paper is to update the NZ Council financial position to the month ended 31 October 2018. To date the Net surplus of \$42,921 – against a budget surplus YTD of \$95,772. The main variance areas are the Election overspend and the Regional Audit. Point raised about possibly bringing reserve for elections through into account – this to be explored with Auditor.

## 10. National Financial Report to 31 October 2018

This provides an update on the YTD expenditure by Council against the 13 budgets 17% through the financial year. Overall the combined 13 councils are sitting at 15%. Of total budget spent. However, this is excluding 3 councils (Taranaki, Wellington & CSI) who were unable to submit their figures due to pressure of audits. A further update was provided at the meeting with the 3 council figures included.

North Canterbury, along with Auckland/Waikato, CSI and Southland operates on a cash basis rather than accrual.

## 11. Legal/RMA Fund Applications

Two applications have been received seeking approval by the New Zealand Fish and Game Council (NZ Council) for funding from the national legal fund for legal costs. These are:

- 1. Otago Fish and Game Council for the Lindis Minimum Flow Plan Change
- 2. Southland Fish and Game Council for the Proposed Southland Water and Land Plan.

#### **11.1 Otago application**:

Two councillors spoke in support of the Otago application and provided background explanation. It was discussed how the EC does not set precedents, so how helpful this case would be for the other rivers in the same position was unknown. There were questions about the quality of the documentation to support the application, noting that \$330k had been approved so far, and that there was a \$64k over spend to date, meaning over \$390k had been spent and one week of the hearing was to come. It was noted that this seemed to be an extraordinary amount of money for an EC case and some understanding about why it was so expensive was needed. It was noted if the \$180k was approved this would mean a total spend of \$520k. It was assumed this would make it the most expensive single EC case ever. It was also noted that the request for another \$180k was based on assumed costs, not on any cost estimates provided in the application backed up by other documentation. It was also noted that the NZC reserves are down to 30% below the 50% currently required in policy. It was also noted that the Otago reserves were well above 30% based on the last information we received.

NZ Council approves for the \$180,000 to come from Otago reserves, subject to a detailed breakdown on the costs to date and anticipated, and subject to Otago being able to fund the \$180k from reserves without going below their 30% reserve level.

Details of breakdown has been provided with application and supporting documents. Impact is going to be across the whole region. Noted this could go on for some time with appeals.

## **12.** Setting National Policy

National policy is designed to provide guidance, cohesion and direction that can be consistently applied across the organisation. This item seeks agreement on the process for setting national policy.

#### That the NZ Council:

- 1. <u>Note</u> that national policy provides guidance, cohesion and direction for all 13 Fish and Game Councils.
- 2. <u>Agree</u>, subject to any modifications determined at the November 2018 NZ Council meeting, that this policy be approved for consultation with Fish and Game Councils.
- 3. <u>Agree</u> that once approved, this policy be consulted with Fish and Game Councils to seek feedback by 17 May 2019, with the intention of it becoming national policy at the June 2019 NZ Council meeting.

# **13. Bequest Policy**

The purpose of this item is to establish a uniform policy relating to the acceptance and utilisation of bequests.

Correct FGHNZ in paragraph 18 of policy.

Note, this is a bequest policy, not a trust policy.

Changes were agreed to paragraph 16 and 21:

Para 16 – "Where possible, agreed bequests should be allow flexibility, while considering but give *pre-eminence* to the wishes of the donor.

Para 21 – A council must inform the NZ Council when an offer a bequest approach has been made and follow this with a report of acceptance or decline of the bequest and under what conditions an offer of a bequest has been made, how it is to be established and the conditions of the bequest.

#### That the NZ Council:

- 1. <u>Agree</u> to receive the letter from Eastern Fish and Game Council dated 12 November 2018 on the need for a national bequest policy.
- 2. <u>Note</u> that a bequest policy will provide guidance and consistency for all 13 Fish and Game Councils.
- 3. <u>Agree</u>, subject to any modifications determined at the November 2018 NZ Council meeting, that this bequest policy be approved.
- 4. <u>Agree</u> that once approved, this policy be consulted with Fish and Game Councils to seek feedback by 17 May 2019, with the intention of it becoming national policy at the June 2019 NZ Council meeting.

# 14. Options to Increase LEQs

In July 2018, the NZ Council asked the Licence Working Party (LWP) to prepare a report with options to increase total LEQs (Licence Equivalents – Adult Whole Season) by a minimum of 1,800 and report to the November 2018 meeting.

Discussion promoting the view that there are too many categories, all offering discounts. Would licence holders accept returning to a simpler selection?

CE undertook to cost a survey of licence holders with Steve Doughty. The survey to include a question on return to the previous licence model or some variation to it (i.e. reduce choice on offer).

Resolved: (Chris Owen/Dan Isbister)

- 1. To defer adjusting licence category fee ratios to generate more revenue until supportive research on likely consequences is completed.
- 2. To develop a scoping paper of what would be required to analyse the impact of all licence categories and pricing and the cost of doing this.
- 3. To support a budget for completing this project with urgency before licence fees are set for the 2019/20 fishing season.
- 4. To support the R3 project and its most recent initiatives.

# 15. 2018/19 NZ Council Strategic & Three-year Business Plan

The 2018/19 Business Plan is based on the Strategic Plan considered by NZ Council in November 2017 and approved in March 2018.

This is something for the new council to review early in 2019.

Note include routine audits in business plan.

# 16. Game Notice – Issues requiring NZC consideration

Regional Fish and Game Councils under 26Q(i)(b)(iii) of the Conservation Act 1987 are to formulate and recommend to the New Zealand Fish and Game Council conditions for the sport fishing and game seasons. Where such recommendations involve ethical consideration or significant changes to the Notice they should be discussed nationally. Those involving population and harvest controls of a local nature should be dealt with regionally. Two Game Notice matters raised for NZ Council consideration are the taking of game using Australian harriers and a change to the game hunting code of conduct.

Include promotion of other non-toxic options, i.e. non-plastic wads.

- **1.** Note the request to allow a change in Northland Fish and Game regional game regulations to allow the taking of game using Australian Harriers.
- 2. Agree that such a request involving population and harvest controls is best dealt with regionally.

- 2. Agree that feedback on a new code of conduct be requested in time for the April 2019 NZ Council meeting to enable any adopted change to be reflected in the preparation of the 2020 Game Bird Hunting Guide booklets.

# 23. Review of Fish and Game Council 2018 Elections

This item provides an analysis of the 2018 electoral results. Of the nine councils with elections in 2018, an average of 29.9% of eligible licence holders had indicated that they wished to go on the electoral rolls. When it came to voting, only 28.9% of those on the electoral roll did so (compared to 27.9% in 2015 and 20.4% in 2012).

- 2. Consult and ask for comment from Fish and Game Councils by 29 March 2019.

## 28. Meeting dates

Two issues raised by managers over proposed dates for 2019 were discussed (relating to the timing of NZ Council meetings as they impact on the annual budget setting process by Fish and Game Councils:

1. How to run the process and

2. The timing.

Alternative dates have been put forward by the NZ Council CE– 29<sup>th</sup> March & 5<sup>th</sup> April.

Discussion resulted on the necessary steps before bids are considered by NZ Council.

It was agreed, there was merit in NZ Councils putting its strategic plan forward and setting out its priorities for the year against which other Fish and Game Council interests could be assessed. These would include R3, and CPI which most Councils included.

It was agreed the 5<sup>th</sup> April should be the new meeting date and this would require papers on contestable funding bids to be submitted by 22 March.

It was recognised that regional manager concern was over having to confirm OWP in February rather than March.

The NZ Council agreed having managers rank contestable bids was useful. It was noted that final decisions on contestable funding bids and Fish and Game council budgets was the responsibility of the NZ Council.
